What is a battery energy storage system?

Battery energy storage systems (BESS), which enable utility companies and grid operators to access pools of surplus renewable energy on demand that would otherwise be wasted, play a central role in the global energy transition.

How will neovolta's acquisition transform its competitive position?

"This transaction fundamentally transforms NeoVolta's competitive position," said Ardes Johnson, Chief Executive Officer of NeoVolta. "We expect this acquisition to be immediately accretive to both revenue and gross margins."

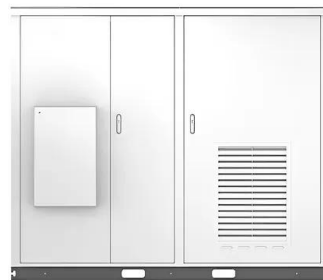

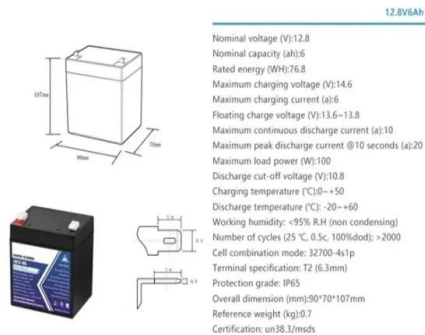

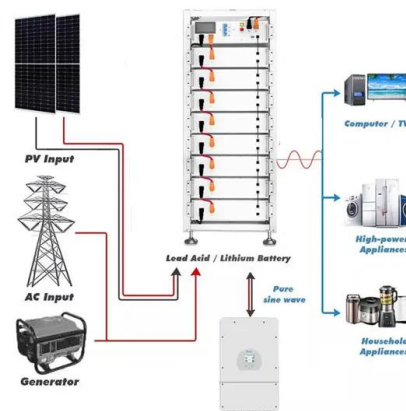
