Performance warranty: A performance warranty is a guarantee that the storage system will maintain specific performance standards over a longer period—often between 15-20 years.

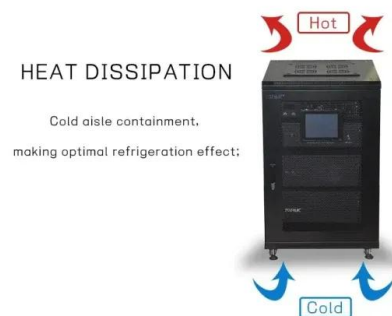
