Other Duties and Charges: Ghana collects numerous duties and charges on imports in addition to the customs tariff and VAT.

How is VAT calculated in Ghana?



VAT: Ghana raised its VAT to 15% in 2022. VAT is calculated by multiplying the VAT rate times the sum of the CIF value of the good and the regular duty as well as all of the other duties and charges below, for a cumulative rate of more than 23% in many cases.

What are Ghana import duty exemptions?

There are also Ghana import duty exemptions in place for privileged persons and institutions, as granted by law. The categories of privileged persons are: Blind, deaf, and dumb persons. How are goods classified in Ghana?

Ghana currently uses the Harmonized System (HS) Customs Code to classify goods. Tariffs are based on value (ad valorem) or weight or volume (specific) and are subject to change. Most goods, unless they are exempt from customs duties, are subject to an import duty, Value Added Tax (VAT), and certain other fees and charges.

What are Ghana's five-band tax rates?

Under the ECOWAS Common External Tariffs, Ghana operates five tax rates: 10% - Inputs and Intermediary Products (Semi-Finished Goods). Note: These rates are not only for Import Duty; they are also an imposition of the following:.

What is the average MFN applied tariff rate in Ghana?

Ghana's average Most-Favored-Nation (MFN) applied tariff rate was 12.1% in 2020 (latest data available). Ghana's average MFN applied tariff rate was 15.8% for agricultural products and 11.5% for non-agricultural products in 2020 (latest data available) VAT: Ghana raised its VAT to 15% in 2022.
