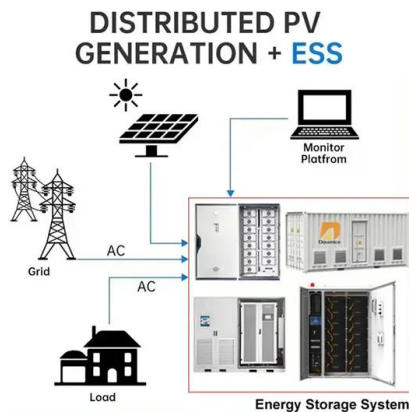


Overview

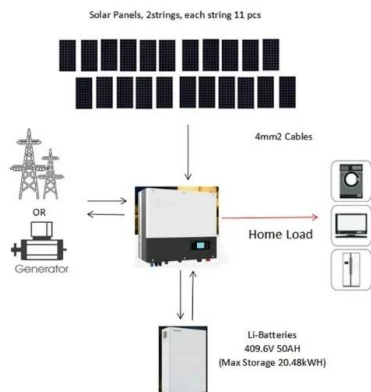
