### **Overview**

Where does Lyten manufacture lithium-sulfur batteries?

San Jose, CA & Luxembourg – July 1, 2025 – (BUSINESS WIRE) – Lyten, the supermaterial applications company and global leader in lithium-sulfur batteries, announced today the acquisition of Northvolt's Dwa ESS operations in Gdansk, Poland, a 25,000 square meter (270,000 sq ft) battery energy storage systems (BESS) manufacturing and R&D facility.

Who owns Northvolt batteries?

Founded in 2016 by former Tesla executive Peter Carlsson and former Airbus manager Paolo Cerruti, Northvolt gained attention for its lithium-ion batteries for EVs and energy storage. The company built partnerships with Volkswagen, BMW, and ABB, aiming to deliver sustainable, high-quality batteries for Europe's green energy future.

Who owns Blackstone battery energy storage system?

In Q4 2023, renewable energy company Octopus Investments Australia, which is majority owned by the UK-based Octopus Group, acquired the Blackstone Battery Energy Storage System. With an expected enterprise value of US\$514 million once operational, it is the largest proposed battery project in the state of Queensland.

Does Lyten own Northvolt?

As part of the deal, Lyten will acquire Northvolt's remaining assets in Sweden and Germany. The deal includes the flagship Northvolt Ett and Ett Expansion facilities in Skellefteå, the Northvolt Labs R&D center in Västerås, and the Northvolt Drei project in Heide, Germany. Lyten is also acquiring all of Northvolt's remaining intellectual property.

What is the largest proposed battery project in Queensland?

With an expected enterprise value of US\$514 million once operational, it is the



largest proposed battery project in the state of Queensland. Q4 2023 saw construction start on the first stage of the Melbourne Renewable Energy Hub.

What makes Lyten lithium-sulfur batteries unique?

Lyten Lithium-Sulfur batteries have unique characteristics that make them ideally suited to meet rapidly growing demand for BESS: a broader operating temperature range especially in hot conditions, improved safety, and the ability to be made from abundantly available, low-cost materials found throughout the US and Europe.


