Overview

What are tax credits for wind & solar power?

Tax credits supporting investment in wind and solar electric power are complex, and claiming those credits can involve parties beyond the investor and the federal government. In the case of transferred tax credits, the business that buys the tax credit may also be involved.

Are wind projects eligible for tax credits?

Accordingly, wind projects placed in service after Dec. 31, 2021, are eligible to receive tax credits at full value, rather than the reduced values under the old law. The PTC extension comes at a price.

What is the section 45 production tax credit (PTC) for wind projects?

Before the enactment of the IRA, the Section 45 production tax credit (PTC) for wind projects was available only to facilities that began construction before Jan. 1, 2022. The PTC rate for wind projects was subject to the phased reductions summarized below: Wind projects that began construction before the end of 2016 – 100 percent.

Can I elect a wind project in lieu of a PTC?

Election Into the Investment Tax Credit The ability to elect the investment tax credit (ITC) in lieu of the PTC was extended to wind projects that begin construction before the end of 2024; however, the current ITC phaseout would continue to apply for any wind project placed in service before Jan. 1, 2022.

Do wind projects qualify for a refundable PTC?

Wind projects owned by the tax-exempt entities described above and placed in service after 2022 can qualify for the refundable credit. Wind projects owned by taxable entities are not eligible for a refundable PTC, but instead can take advantage of the new transferability rules (discussed below). **Direct Transfer of the Tax Credits.**



How will state taxes affect renewable generating companies?

This increase in renewable generating companies will have state tax implications. “States may impose several taxes on renewable generation companies, including income tax, franchise tax, capital stock tax, gross receipts tax, property taxes and sales and use taxes,” Wade and Herzberg wrote.
